## **Regular Session -**

The City Council of the City of Lanett, Alabama, met in regular session on Monday, January 3, 2022, in the Council Chambers of the Lanett Municipal Complex at 6:00 P.M.

Council members present were Tony Malone, Tamalita Autry, and Angelia Thomas. Mayor Heard presided over the meeting.

Rev. Rodney Jones said the invocation and Mayor Heard led the pledge of allegiance.

Councilmember Malone made the motion to adopt the prepared agenda. Councilmember Thomas seconded the motion. Motion unanimously carried.
