Vote Canvass Session -

The City Council of the City of Lanett, Alabama, met on Tuesday, September 1, 2020, in the Council Chambers of the Lanett Municipal Complex at 1200 P.M.

Present were council members Jamie Heard, Charles Looser, Angelia Thomas and John Motley. Mayor Kyle McCoy presided over the meeting.

Mayor Kyle McCoy asked for an approval of the Agenda. A motion was made to approve the agenda by council member Thomas and seconded by council member Heard.

Motion unanimously carried.

At this time Mayor McCoy turned the floor over to Clerk Deborah Gilbert to read out the results of the Municipal Election (prior to adding Provisional Ballots) which was held on Tuesday, August 25, 2020. The results read were as follows:

- In the Mayor's Race Kyle McCoy received 796 and Stanley Roberts received 482
- In District 3 Council Race Charles Looser received 331 and Ronnie Tucker received 195.
- In District 5 Council Race Tifton Dobbs received 107, Tony Moffett received 31 and John Motley received 87.

The Provisional Ballots were opened at this time. There was a total of 11 Provisional Ballots. Five were valid and could be counted. They were opened by City Clerk, assisted by City Attorney Stanley Gray. The results of the 5 were as follows:

- Ballot 1 – Mayor's Race Kyle McCoy, City Council District 3, Ronnie Tucker
- Ballot 2 – Mayor's Race Stanley Roberts, Council District 3, Charles Looser

- Ballot 3 – Mayor’s Race – Mayor’s Race Kyle McCoy, City Council District 3, Charles Looser
- Ballot 4 – Mayor’s Race Mayor Kyle McCoy, City Council District 3, Charles Looser
- Ballot 5 – Mayor’s Race – Stanley Roberts

After counting the 5 Provisional Ballots the following numbers changed:
Kyle McCoy = 799, Stanley Roberts = 484, Charles Looser = 334, Ronnie Tucker = 196. All other numbers remained the same with end results remaining the same.

A motion was made to adopt Resolution 09-20-01, a Resolution to accept the Canvassed results by council member Thomas. Council member Heard seconded the motion. The motion carried unanimously.

An announcement was made of a run-off election between John Motley and Tifton Dobbs to be held on Tuesday, October 6th.

Certificates of Election, which will be filed with the Probate Judge, were presented to Charles Looser and Kyle McCoy by Attorney Gray.

Mayor Kyle McCoy said that there being no further business to come before this Council, motion duly made, the meeting adjourned.
