Regular Session -

The City Council of the City of Lanett, Alabama, met in regular session on Thursday, May 5, 2022, in the Council Chambers of the Lanett Municipal Complex at 6:00 P.M.

Council members present were Tony Malone, Charles Looser, Tifton Dobbs, Tamalita Autry and Angelia Thomas. Mayor Heard presided over the meeting.

Rev. Rodney Jones said the invocation and Mayor Heard led the pledge of allegiance.

Councilmember Thomas made the motion to approve the agenda. Councilmember Autry seconded the motion. Motion unanimously carried.

Councilmember Autry made the motion to approve the minutes of the April 19, 2022 Council Meeting. Councilmember Thomas seconded the motion. Motion unanimously carried.

Councilman Looser had no committee report. He thanked department heads who makes our job a lot easier.
